RFQ MUST INCLUDE THE FOLLOWING COMPULSORY DOCUMENTS:

(a) Valid tax clearance certificate or SARS pin, (b) Proof of registration with CSD, (c) A Certified copy of Company registration, Company profile, (d) A certified copies of Municipal rates & taxes of Company and Directors (not older than 3 months in arrears) within the area of jurisdiction, (e) Dully completed and signed MBD forms in the bidding document, and (f) A Certified ID copy (ies) of director(s) (g) Share certificate for Preferential Points, CIDB 2 CE or higher

NB:

- Failure to submit any of the required documents will result in the bidding proposal being disqualified.
- All returnable documents should be packaged properly showing indexes, the tender document should not be tempered with; and
- People who are in the service of the state should not tender.
- Certified copy (ies) older than three months will be regarded as invalid therefore bidder(s) will be disqualified, bidders to be evaluated on 80/20-point system and only market related price will be accepted
- COIDA certificate to be provided after appointment
