Bids must include the following **compulsory** documents: a **valid original Tax Clearance Certificate, a certified or original copy of Company Registration, Company Profile with traceable relevant experience, a valid Municipal Services Account Statement of the company within the area of jurisdiction (not older than three(3) months), Proposed team with CVs, company registration with Professional bodies, proposed team organogram, Performance Guarantee, certified ID copies of members, Joint Venture Agreement and Power of Attorney in case of Joint Ventures, Workman's Compensation Registration Certificate and Proof of payment for purchase of tender document.** All MBD forms in the document must be fully completed and signed. **NB: Failure to submit any of the required documents will result in the tender proposal being disqualified.**

Tenders fully completed shall be sealed in an envelope marked with both **"Tender Number and Tender Description"** of the above mentioned projects and be deposited in the tender box at the Bushbuckridge Local Municipality, Head Office in Bushbuckridge R533 Graskop Road, opposite

Mapulaneng DLTC, or posted to the address mentioned below, not later than **12h00 on the closing date.**

Bidders must submit an **original or certified copy of a B-BBEE certificate** to claim contribution. However, bidder shall not be disqualified for not submitting a certificate substantiating the B-BBEE status level of contribution nor is a non-compliant contributor. The validity period shall be 90 days from the closing date.
