BIDS MUST INCLUDE THE FOLLOWING COMPULSORY DOCUMENTS : A VALID ORIGINAL TAX CLEARANCE CERTIFICATE, PROOF OF REGISTRATION WITH CSD, COMPANY REGISTRATION, COMPANY PROFILE, A COPY OF B-BBEE STATUS LEVEL CERTIFICATE AND MUNICIPAL RATES & TAXES AND MUNICIPAL SERVICES ACCOUNT (NOT IN ARREARS) WITHIN THE AREA OF JURISDICTION. ALL MBD FORMS IN THE BIDDING DOCUMENT MUST BE FULLY COMPLETED AND SIGNED, A COPY OF COIDA CERTIFICATES, CERTIFIED ID COPY OF DIRECTORS. NB: FAILURE TO SUBMIT ANY OF THE REQUIRED DOCUMENTS WILL RESULT IN THE BIDDING PROPOSAL BEING DISQUALIFIED. BIDDERS WHO DO NOT SUBMIT THEIR VALID B-BBEE STATUS LEVEL CERTIFICATES SHALL NOT QUALIFY FOR PREFERENCE POINTS FOR B-BBEE CONTRIBUTION BUT SHALL NOT BE DISQUALIFIED FROM THE BIDDING PROCESS. ALL RETURNABLE DOCUMENTS SHOULD BE PACKAGED PROPERLY SHOWING INDEXES, THE TENDER DOCUMENT SHOULD NOT BE TEMPERED WITH.

NB: People who are in the service of the state should not tender. All Providers needs to be active on the central suppliers database (CSD) and attach registration confirmation on each application
