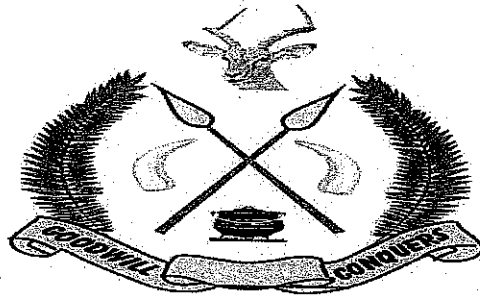

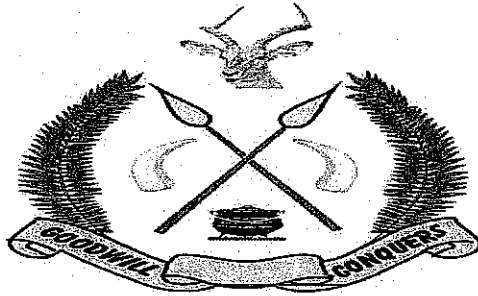



- c) That the Property Rate Tariffs be capped for the next 2 financial years.

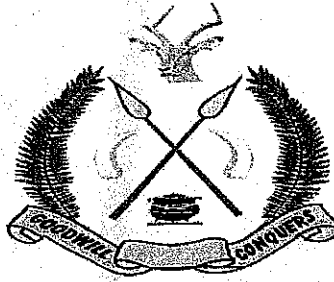
